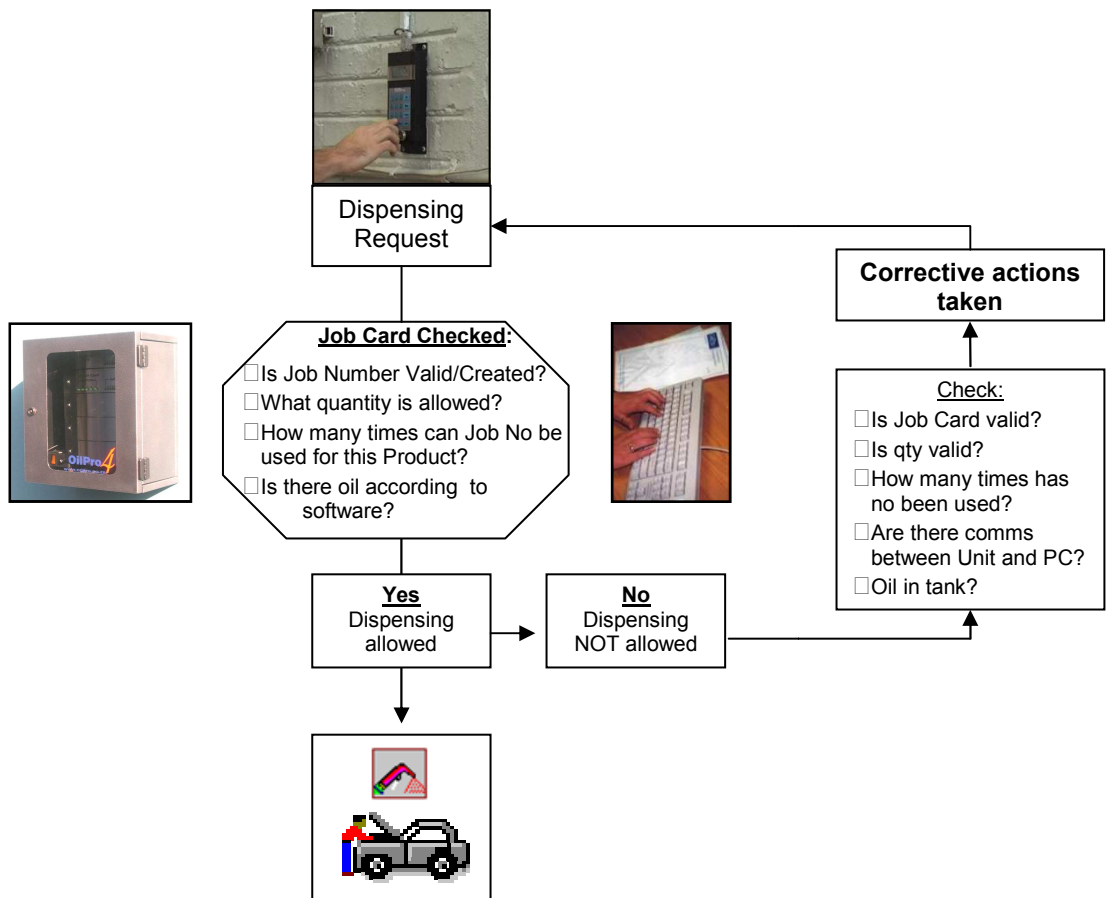


Levels of Control

Level 3 - Job card & Quantity Validation	
<ul style="list-style-type: none"> ◆ System logs all transactions: <ul style="list-style-type: none"> ○ Job number used ○ User that dispensed ○ Group / Cost centre ○ Vehicle type ○ Bay dispensed at ○ Date/Time of dispensing ○ Quantity dispensed ○ Times Job number used ○ Vehicle registration number ◆ System checks the validity of the job number used, i.e. <i>only</i> job numbers in system software are allowed by the system. <ul style="list-style-type: none"> ○ Job card has to be created before oil can be dispensed ○ Quantity allowed limited to what is specified in job card when job card is created. ○ Incorrect / invalid job numbers will be blocked. No dispensing is allowed with invalid job numbers ○ System displays quantity allowed on keypad. ○ System will only dispense quantity allowed on job card, not more. ◆ Job card has to be closed (Except with Kerridge integration). 	<ul style="list-style-type: none"> ◆ System and computer is interactive, i.e. if computer is off, no dispensing will be allowed. ◆ If computer is off (e.g. over weekends) the mechanic can dispense by using his 3 digit code issued to him only to use as the first 3 digits of his job numbers. ◆ Administrator will be able to dispense on any job number and any quantity even if computer is off.

Dispensing process with Level 3 Control activated

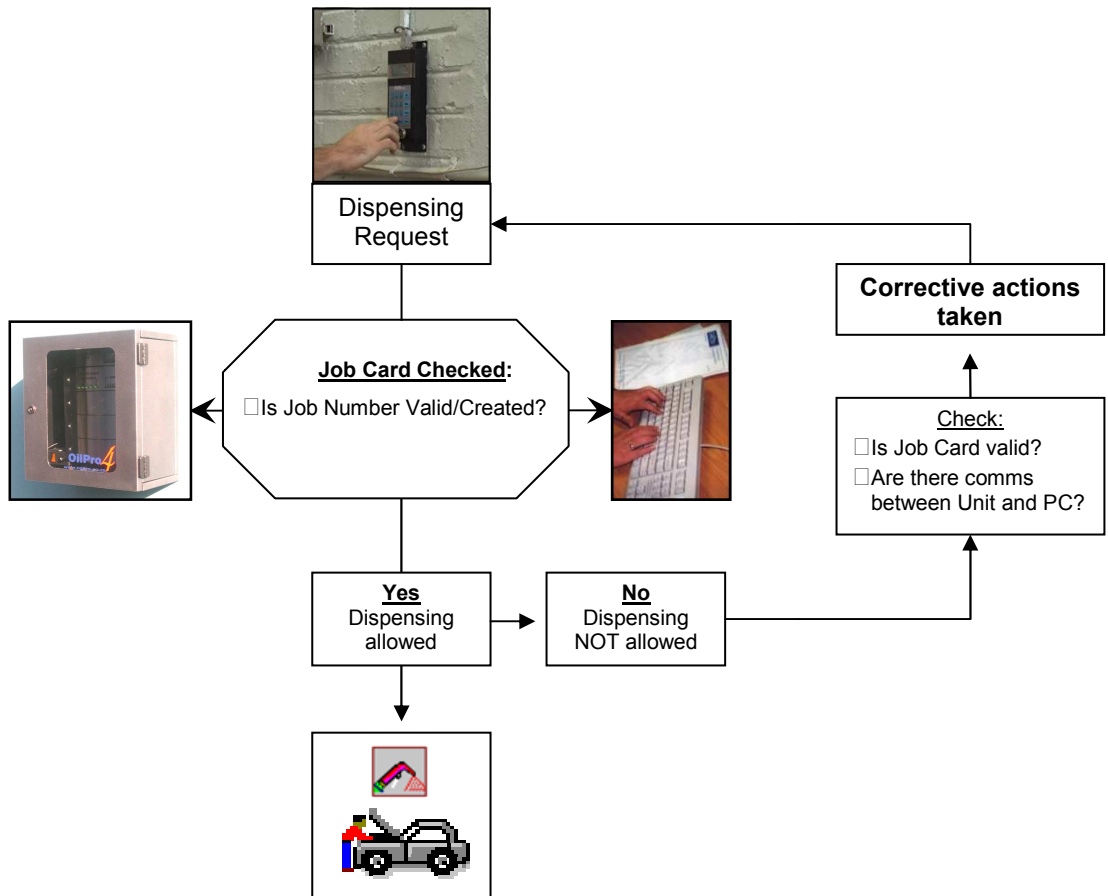
